**REQUIRED INSTRUCTIONS:** Non-Delegated Correspondents should select from the Appraisal Management Companies (AMCs) listed below to establish a customer profile with the AMC specifically for the NewRez Non-Delegated Correspondent Program. This list of AMCs has been approved by NewRez ensuring that all appraisal orders intended for delivery meet NewRez Appraisal and Appraiser Policies. The account set-up is independent of the NewRez Wholesale program. Please ensure you establish your own contract and pricing with the AMC of your choosing. When contacting the AMC, you must state that you wish to set-up an account to submit appraisal orders specifically for the NewRez Non-Delegated Correspondent program. Your organization MUST approve the AMC as Lender Agent in UCDP to upload appraisals on your behalf to obtain successful SSRs. SSRs must be provided to NewRez with the appraisal.

**Non-Delegated Correspondents are required to use a NewRez approved AMC for all Shellpoint portfolio loans or SMART series products.**

**For VA, FHA or Conventional loans it is not required to use an approved AMC. However, the AMC utilized must be independent of the lender, Lender's Affiliates and subsidiaries and is not involved in the loan transaction in any way except as the appraiser.**
